  - 3.1.3 will comply with, and use their best efforts to ensure the Company complies with, applicable governmental laws, rules and regulations; and
  - 3.1.4 will promptly report any violation or suspected violation of this Code to the Audit Committee or to a responsible member of Senior Management of the Company.

The foregoing are statements of mandatory conduct, and any waiver of, or amendment to, the requirements set forth in this Code will be subject to public disclosure. Any waiver of this Code with respect to a Senior Financial Executive shall be made only by the Board of Directors or a committee thereof. Violations of this Code shall be investigated and appropriate disciplinary action will be taken in the event of any such violation, up to and including termination.
